The ITIC - International Teacher/Professor Card was introduced in 1984 to make it easier and less expensive for teaching professionals to travel by providing teachers, professors and instructors with a common photo identity card that is acceptable around the world

You can visit www.isic.org to check on services and benefits for ITIC holders.

The following are eligible to apply for the ITIC:

1. All bona-fide full-time teachers, professors and teaching instructors engaged as full-time teaching staff at a recognised educational establishment.
2. Such eligible persons must be employed at a recognised educational establishment for a minimum of 18 hours per week and minimum of one academic year.
3. There is NO age limit

Validity:

In Malaysia, the ITIC is valid for 12 months date of issue.

The ITIC is distributed in over 40 countries around the world and is endorsed by UNESCO – United Nations Educational, Scientific and Cultural Organisation . For More Details check out the website: www.isic.org

The BENEFITS and DISCOUNTS to the ITIC holder are at the moment limited and efforts are being made worldwide to expand the benefits and discounts to ITIC holders.

Currently discounts are available for ITIC holders in Armenia, Belarus, Chile, China, Colombia, Costa Rica, Czech Republic, Dominican Republic, Estonia, Hungary, Ivory Coast, Latvia, Lithuania, Panama, Peru, Poland, Slovakia, USA, Venezuela. MSL Travel Sdn Bhd is the Exclusive Representative-ER for the ITIC in Malaysia. The ITIC is issued at MYR 50.00 plus 0% GST = MYR 50.00. One Passport Size photograph is required. Proof of TEACHER STATUS can be a letter from the educational establishment stating your employment/services as a teacher or professor or educational instructor.

How to become an ITIC holder

If you are a full-time teacher, professor, lecturer, instructor , you are eligible to become an ITIC holder!

Simply complete the application form and either post it or take it to your nearest ITIC issuing office. In addition to this form, the following items are required:

- **Proof of your full-time TEACHER status**

A letter from a recognised educational establishment stating that you are a full time teacher, lecturer, professor, instructor employed at the establishment for a minimum of 18 hours per week and a minimum of one academic year.

If you are a Foreigner teaching in Malaysia, a copy of your work permit and passport is required in addition to the above.

Contact the ITIC issuing office for more details if required.

- **MYR 50.00**

It takes only 5 minutes to issue the ITIC. If you apply for it in person and your application is in order, you only have to wait for your turn which only depends on how busy the office is.

If you apply by mail, how fast you get ITIC depends on the postal services. Please ensure that you have included your:

- **proof of teacher status** (*work permit & copy of passport if you are a foreigner teaching in Malaysia*)
- **correctly completed application form**
- **ONE passport size photo** (*we do not accept scanned/digital photos*)
